KATS 4010 is a water-based coating that both prevents rust and enhances appearance. The coating is black and semi-transparent, with an attractive high gloss finish. It is suitable for use on both ferrous and non-ferrous metals.

KATS 4010 covers approximately 640 sq ft per gallon (15.7 sq meters per liter).

Ambient temperature should be 45°F to 90°F (7°C to 32°) and surface temperature should not be below 45°F (7°C) or above 200°F (93°C). Apply coating at a 2.5 mil wet film thickness. Dries to a 0.5 mil dry film.

Application equipment can be automatic or manual.
