# **RUST PREVENTIVE COATING - CLEAR**

KATS 4024 is a waterborne coating that prevents rust and enhances appearance. The coating is clear and transparent, with an attractive high gloss finish. It is suitable for use on both ferrous and non-ferrous metals.

KATS 4024 covers approximately 640 sq ft per gallon (15.7 sq meters per liter).

Ambient temperature should be 45°F to 90°F (7°C to 32°C) and surface temperature should not be below 45°F (7°C) or above 200°F (93°C). Apply coating at a 2.5 mil wet film thickness. Dries at a 0.5 mil dry film.

Application spray equipment can be automatic or manual.
