Kwik Kleen is a biodegradable, water-based cleaner. This versatile product can be used for removal of:

- Dirt

When used as a degreaser or paint stripper, place the item into the Kwik Kleen. If necessary, agitate the solution. Remove the item and rinse with clean water.

When using as a floor or general purpose cleaner, add Kwik Kleen to water at a rate of one cup per gallon. Use at higher concentrations for removing grease.
