Removing tar, asphalt, grease, and carbon: Use undiluted for difficult deposits. Rinse with water.

General commercial cleaning and degreasing: Dilute 4 ounces (half a cup) of Bright Knight™ Gold 50 Cleaner to 1 gallon of warm water and apply to equipment, floors, walls, and other soiled surfaces. Rinse with clean water.

Drain Opener: Pour in 8 ounces of Bright Knight™ 50. Allow 30-60 minutes, and then flush with hot water.
